INSTRUCTIONS

Partial applications will not be reviewed. Permit Application must be:

- typed or neatly printed;
- complete with all necessary documentation as prescribed in Louisiana Administrative Code Title 70, Part IX, Subpart B, including:
 1. Certificate of Insurance listing the Louisiana Department of Transportation and Development as a certificate holder.
 2. Certificate of Good Standing with the Louisiana Secretary of State (Documentation)
 3. Agent for service of process in the state of Louisiana.
 4. Nondiscrimination policies for riders and drivers (Affidavit/Documentation)
 5. Zero tolerance policy (Affidavit/documentation)
 6. Fare Transparency (Affidavit/documentation)
 7. Digital Identification Network (Affidavit)
 8. Electronic Receipt (Affidavit)
 9. Rider Non-Payment by cash to Driver-Policy (Affidavit)
- Signed by a duly designated and/or authorized representative or officer of the company, with attached corporate resolution or other certified authorization to act and sign on behalf of the Applicant/Transportation Network Company;
- Policy and/or affidavit, sworn to and duly notarized;
Submitted to the Louisiana Department of Transportation and Development, Attn: Deputy General Counsel, Legal Division Re: Transportation Network Companies, P.O. Box 94245, Baton Rouge, La. 70804-9245
- at least **30 days prior to planned operations within the state of Louisiana.**
- **Renewal application – shall be submitted annually by July 1.**
- **All permits are approved and continued at the discretion of the Louisiana Department of Transportation and Development.**
