
How to run a CP-2a Comparison Report

This report is used to check the total amount documented as paid to a Disadvantaged Business Enterprise (DBE) Contractor. This report is available to the user roles Vendor Subcontract Payments, LPA Subcontract Payment Approvals, Subcontract Payment Approvals and Compliance Program Full. There are four steps in this process.

Before starting make sure you are in one of the user roles that allow you to run the report.



1. From the start page, go to the global actions button and from the dropdown list select generate report.




Select the CRL-022 CP-2A Payment Comparison Report. Once selected the report query page will load.
