We hope you will take advantage of this opportunity to provide input on the proposed LA 95 and Lexington Drive Roundabout Project in Duson. Thank you for attending this meeting and for providing input.

### PRELIMINARY PROJECT DESCRIPTION

This proposed project can be found in the Town of Duson at the intersection of Lexington Drive and LA 95 located just north of Interstate-10. The Town of Duson has experienced economic development and commercial growth north of Interstate 10 with future anticipated growth. There was a concern that this intersection lacks the capacity to support this growth. As a result, a feasibility study was conducted to determine the deficiencies in this intersection, if any.

The study included a traffic analysis which indicated that approximately 11,000 vehicles travel through the intersection daily and the intersection currently operates at a poor Level of Service as a two-way stop-controlled intersection, with excessive delays for existing and future traffic demand. The traffic analysis demonstrated that a single lane roundabout at this intersection would operate with an improved Level of Service for the future design year. Additionally, it is expected that the proposed roundabout will reduce total crashes and reduce crash severity as compared to the existing intersection, as according to the study from the Transportation Research Board: Safety Effect of Roundabout Conversions in the United States: Empirical Bayes Observational Before-After Study. Therefore, the installation of a roundabout at the intersection of LA 95 and Lexington Drive was adopted based on the results of the traffic analysis and expected safety improvements.

The proposed project consists of the design and construction of a single lane roundabout at the LA 95 and Lexington Drive intersection. The roundabout is to be constructed in accordance with LA DOTD standards, including the roadway approaches, slip lanes, splitter islands, truck aprons, storm drain system, and culverts.

#### PRELIMINARY PURPOSE AND NEED

The preliminary purpose and need of the project is to aid traffic flow and reduce the potential for crashes at the intersection of Louisiana Highway 95 and Lexington Drive located just north of Interstate-10 in Duson. The proposed roundabout is expected to improve safety by reducing speed and improving the flow of traffic resulting in a reduction in severe crashes. In addition, the proposed roundabout will improve the intersection's ability to support economic and commercial growth in this area of the Town.
