
Station 5: Comment Table

PRELIMINARY PROJECT DESCRIPTION

The Louisiana Department of Transportation and Development (DOTD), in conjunction with the Federal Highway Administration (FHWA), proposes the construction of a roundabout at the intersection of LA 3211 (Northwest Blvd) and Yokley Road in the City of Franklin in St. Mary Parish, LA. Additional ROW will be required.



PRELIMINARY PURPOSE AND NEED

The preliminary purpose and need of the project is to reduce the potential for crashes, the severity of crashes and congestion at the intersection LA 3211 (Northwest Blvd) and Yokley Road. The 2028 projected Average Daily Traffic for C.S. 851-13 is approximately 4,850 vehicles per day which is expected to increase to as high as approximately 5,925 vehicles per day by the year 2048.

ENVIRONMENTAL PROCESS

A Categorical Exclusion environmental document, is being prepared for the proposed project. As part of the environmental process, LADOTD will address comments from this meeting; complete data review, field work, and the environmental document.
