PUBLICATION OF T-INTERSECTION GUARD RAIL SPECIAL DETAILS AND REVISED

TEMPORARY PRECAST BARRIER SPECIAL DETAIL

Revision No. 1 Summary:

Verbiage was added stating that the T-intersection guard rail detail is not allowed on N.H.S. routes, as stated in Note 1 on the special detail. All other content of BDTM.78, as published on January 25, 2018, remains unchanged.

T-Intersection Guard Rail Special Details:

Effectively immediately, use of the new T-intersection guard rail special details (full-sized and letter-sized), with a signature date of January 22, 2018, shall be implemented for projects using the new MASH guard rail standard plans. Note that the T-intersection detail is not allowed on N.H.S. routes, and use of the T-intersection special details now requires a design waiver.

The new MASH guard rail standards do not include a T-Intersection layout, as there are currently no MASH compliant T-Intersection details. However, there will still be an occasional need for such a layout. Thus, these T-Intersection details are a new arrangement of the T-intersection details formerly included in the old GR-200 details, with a few changes to the notes to make them compatible with the MASH guard rail set.

Temporary Precast Barrier Special Detail:

Effectively immediately, use of the new temporary precast barrier special detail with a signature date of December 21, 2017 shall be implemented for all projects.

A note was added to the detail which requires that temporary precast barrier manufacturers be listed on the Approved Materials List.

All new details have been published in ProjectWise for use.
