Please accept this amendment to the Transit Element of the Regional Planning Commission's FY24 Transportation Improvement Program (TIP) for the New Orleans Urbanized Area (UZA) for inclusion in the State Transportation Improvement Plan (STIP).

In the New Orleans UZA, the Regional Transit Authority (RTA) of Orleans Parish is submitting three amendments to the Transit TIP. First, RTA has been awarded a 5339 (c), Low No Emissions grant, which will fund the acquisition of electric buses and charging infrastructure. Second, RTA is consolidating various line items under its Section 5337 rail program into Preventative Maintenance. Finally, RTA is merging Section 5337 (HOV), Administrative Support into Preventative Maintenance (HOV).

Change BRT (Roadway Improvements) \$2.531M @80/20 from FFY 2024 to FFY 2025 in NHPP (Y001)

### Modifications for FY 2020 (STP>200K)

• Change Plank Road BRT (North Transfer Center) \$3.3M @80/20 from FFY 2020 to FFY 2025 in STP>200K (transfer funds)

### Modifications for FY 2024 (STP>200K)

Change BRT (North Transfer Center) in \$1.7M @80/20 from FFY 2024 to FFY 2025 in STP>200K (transfer funds)

#### Modifications for FY 2023 (STP>200K)

 Remove Rolling Stock (3 Electric Buses) in \$2.888M @80/20 from FFY 2023 in STP>200K, readjusted with above two BRT Transfers.
