Also, and most importantly, this memorandum serves to inform you that the latest version (Version 2008.1 dated September 17, 2008) of the LRFD Bridge Design Manual has been published and is posted on the LADOTD Bridge Design Section website under Bridge Design Manuals.

Effective November 21, 2008, all projects shall implement the revisions included in Version 2008.1 with the exception of the following two items. These items shall be implemented with the included instructions.

Item (1) – Chapter 5 Deck Design

The new version requires that the reinforcement spacing in the deck at each direction shall not exceed seven (7) inches for crack control. This requirement shall be implemented for all projects prior to 95% final plan stage. Any exceptions shall be approved by the LA DOTD Bridge Engineer.

Item (2) – Chapter 3 Load

Eight (8) Louisiana Special Design Vehicles in Figure 3.1 shall be included in design for Strength II limit state. This requirement shall be implemented for all projects in preliminary design stage.
