The following general conditions and standards shall apply:

FIRST: The applicant must own the property to be moved.

SECOND: Crossings are to be made at as nearly right angles to the highway as possible.

THIRD: All necessary precautions must be observed for the protection of the traveling public and undue delay to traffic will not be permitted.

FOURTH: All excavations within the limits of the right-of-way shall be backfilled and tamped in six inch (6") layers. Where it is necessary to make excavations in the shoulders, the top six (6") of backfill shall be sand, clay, gravel or equivalent. Prior to performing any excavations, the applicant is required to call Louisiana One Call. If installing any underground facilities such as cable or conduits, the applicant must be a member of Louisiana One Call. In addition, the applicant must contact DOTD at 1-800-259-4929 or DOTD-FiberLocates@la.gov at least 24 hours prior to performing any excavation on DOTD Right-of-way (either for installation or maintenance).

FIFTH: All property shall be moved in accordance with the DOTD's Standards Manual for Accommodating Utilities, Driveways and Other Facilities on Highway Right-of-Way and in a manner that will not damage the highway surface.

SIXTH: Applicant is required to supply a Traffic Control Plan (TCP) for all crossings.
