SUBJECT: REGULATIONS FOR OPENING FLOOD SECTION CONTROL DEVICES DESIGNED AND BUILT FOR THE PURPOSE OF FLOOD CONTROL ON DOTD MAINTAINED RESERVOIRS

- 1. PURPOSE:** The purpose of this directive is to establish a uniform policy for the opening of Water Control Structures, designed and built for the intended purpose of flood control, at Department of Transportation and Development (DOTD)-maintained reservoirs.
- 2. BACKGROUND:** Act 270 of 1984 authorized DOTD to assume responsibility for the operation and maintenance of some 19 reservoir embankments and water control structures throughout Louisiana.
- 3. SCOPE:** This directive establishes policy and procedure for opening reservoir structures designed and built for the intended purpose of flood control.
- 4. POLICY AND PROCEDURE:**
 - A. **RESPONSIBILITY:** DOTD is responsible for the maintenance and operation of some 19 reservoir embankments and water control structures identified in Act 270 of 1984, to maintain their integrity, and to prevent any breach or damage to the existing facility. DOTD is not responsible for lake management. However, DOTD is responsible for flood control structures at the following locations:
 - a. Two (2) Tainter Gates constructed in 2013 on the Lake D'Arbonne Dam in Union Parish
 - B. **Authority:** Flood control structures will be under the authority of the District Administrator and opened according to structure-specific procedures approved by the Department of Transportation and Development and Bayou D'Arbonne Lake Watershed District.
- 5. OTHER ISSUANCES AFFECTED:** All previous directives, memoranda or instructions issued heretofore in conflict with this directive are hereby rescinded.
- 6. EFFECTIVE DATE:** This directive will become effective immediately upon receipt.
