This station consists of a series of maps that illustrate the potential limits of construction super-imposed over aerial photographs. The limits shown on the map are based on the build alternative currently being designed.

Station 4: Real Estate Information Table

At this station, you will find information about the Louisiana Department of Transportation and Development (LA DOTD) Acquisition of Right of Way and Relocation Assistance Program, which is administered under Louisiana law in compliance with the federal laws outlined in the "Uniform Relocation Assistance Act" as amended. If you do not have the brochure explaining the Acquisition of Right-of Way and Relocation Assistance Program, it is available at this station or you can obtain one from the LADOTD District 62 Right of Way Office, located at 685 North Morrison Boulevard in Hammond, LA 70401. US 190W Roundabouts, Slidell OPEN HOUSE PUBLIC MEETING



PROJECT DESCRIPTION

The Louisiana Department of Transportation and Development (LA DOTD) is proposing a project to improve US 190 (Gause Blvd. West) from just west of Badon Road to just east of Maris Stella Avenue. The improvements would include building three roundabouts: one at the intersection of US 190 at Westminster Drive, one at the intersection of US 190 with Sunset Drive and Carroll Road, and one at the intersection of US 190 at Maris Stella Avenue. Some Right-of-Way will be required, and one relocation is anticipated at this time. The total length of project limits on US 190 is approximately 3380 feet.

PURPOSE AND NEED

The purpose of the project is to reduce congestion and improve mobility at the intersection of US 190 (Gause Boulevard West) at Westminster Drive, Carroll Road/Sunset Drive, and Maris Stella Rd. The project is needed because the capacity of the existing signalized intersections are inadequate to meet current and future traffic volumes and are points of some of the heaviest congestion and reduced mobility along the US 190 corridor.

ALTERNATIVES

Currently, one Build Alternative is being proposed to move forward for further consideration. This alternative will construct three, one lane roundabouts: one at the intersection of US 190 with Westminster Drive, one at the intersection of US 190 with Sunset Drive and Carroll Road, and one at the intersection of US 190 with Maris Stella Avenue.

COMPLETING THE ENVIRONMENTAL PROCESS

Comments from this meeting will be summarized and addressed in a public meeting record. This record will be distributed to the public and state libraries before the project will receive environmental clearance. Once all environmental studies are complete, this project will advance to final design.
